

## **DP WORLD STRENGTHENS BOARD WITH NEW APPOINTMENTS TO BOARD OF DIRECTORS**

Prior to this, Mrs. Kamali held senior executive positions at Dubai Customs and Dubai Aluminium Company. Mrs. Kamali holds an MBA from American University of Sharjah and a BSc in Computer Science from Michigan State University. She is an Alumni of INSEAD Business School.

The appointments followed the Board's process for search and selection, and the nominations were put to the shareholders for their approval at the Annual General Meeting that took place today on 28 April 2016.
